

Case Manager Job Description

Classification: Full Time (Salary)

Reporting to the Program Director (PD), the Case Manager will have responsibility for establishing and overseeing care for clients. Case Manager serves as the support staff to clients referred to Present Age. The incumbent is responsible for implementing services for the physical, physiological, educational, relational and spiritual needs of juvenile victims of sexual exploitation and trafficking. This position will be mobile, working in the greater Charlotte area as services are needed.

General Responsibilities:

- Continually grow in personal relationship with Jesus Christ and represent Him and Present Age
 Ministries with upmost integrity and respect
- Maintain accurate documentation and reporting
- Participate in weekly meeting with supervisor to review cases and concerns
- Demonstrate teamwork with peers and assist when able to ensure functions of ministry and fulfilled
- Represent Present Age Ministries at identified community committees
- Other duties as assigned

Specific to Role:

- Develop individual care plans for each client that is trauma informed
- Coordinate and facilitate services in accordance with care plan for each client assigned to case load
- Work with families to identify reunification opportunities and coordinate recreational activities/programs and/or childcare services for eligible parents receiving voluntary supportive services.
- Provide services at children's hospitals, schools, local and private institutions that assist with services and housing for trafficked minors and wherever the case manager is needed or requested for services.
- Coordinate with local, state and federal law enforcement and other systems and organizations to support the victim in leaving the trafficking situation and receiving needed services, providing reporting and documentation as needed.
- Maintain communication with each victim's care team to ensure efficiency and highest quality of service is provided to that child/family.
- Participate in CFT meetings and other meetings as directed by Program Director
- Maintain accurate and timely case notes and statistical records.
- Maintain strict confidentiality regarding all human trafficking victims.
- Participate in internal Care Review Meeting as scheduled on active cases.
- Assist with all required internal and external grant reporting including program output and outcome reports.



Qualifications:

- Personal, active relationship with Jesus Christ; active involvement in local church
- BA in Human Service area (Social Work)
- Minimum of 5 years of relative experience, preferably in working in Human Trafficking Field
- Knowledge of trauma and experience working with adolescents and navigating through the
 resulting issues (including but not limited to: anger, abandonment, depression, PTSD, cutting, eating
 disorders, etc).
- Ability to strategize to establish alternative program options through community partnerships in effort to provide individualized treatment programs for all clients.
- Highly collaborative style; experience developing and implementing strategies with community partners.
 Ability to think out-side of the box to determine solutions and opportunities
- Reliable, dependable and consistent
- Excellent writing and verbal communication skills
- Proficient at Microsoft Office
- Ability to maintain client confidentiality.
- Able to work flexible hours, including evenings and weekends.
- Up to 25% travel required

Neither the acceptance of this application nor the subsequent entry into any type of employment relationship, either in the position applied for or any other position, and regardless of the contents of employee handbooks, personnel manuals, benefit plans, policy statements, and the like as they may exist from time to time, or other Organizational practices, shall serve to create an actual or implied contract of employment, or to confer any right to remain an employee of PAM, or otherwise to change in any respect the employment-at-will relationship between it and the undersigned, and that relationship cannot be altered except by a written instrument signed by the Executive Director of The Organization. Both the undersigned and PAM may end the employment relationship at any time, without specified notice or reason. Statement of Faith

While we are a faith based organization, we do not discriminate or force those we serve to share in our beliefs. We seek to provide quality services as we rebuild trust, restore hope and redefine love for survivors of sexual abuse, exploitation and trafficking.

- We believe that there is one God, eternally existing in three persons: the Father, the Son, and the Holy Spirit (Deuteronomy 6:4; 2 Corinthians 13:14).
- The Bible is the infallible Word of God, inspired by the Holy Spirit. Every word of the Bible is true and correct, and it contains every answer to man's problems (2 Timothy 3:16,17; 2 Peter 1:20,21).
- We believe that Jesus Christ is "the way, the truth, and the life" (John 14:6).
- We believe in the deity of Jesus Christ, His virgin birth, sinless life, miracles, death on the cross to provide for our redemption, resurrection, bodily ascension into Heaven, present ministry of intercession for us, and His return to earth in power and glory (John 1:1,14; Luke 1:26-38; 2 Corinthians 5:21; John 6:19; Romans 3:24; Matthew 28:6; Hebrews 8:1; Hebrews 7:25; Acts 1:11; Luke 21:27).
